NOTICE OF PUBLIC HEARING**

The City of Astoria Planning Commission will hold a public hearing on Tuesday, April 22, 2014 at 6:30 p.m., at the Astoria City Hall, Council Chambers, 1095 Duane Street, Astoria. The purpose of the hearing is to consider the following request(s):

1. Conditional Use CU14-04 by Brad Smithart to locate an arcade as indoor family entertainment in an existing commercial structure at 1084 Commercial (Map T8N-R9W Section 8CB, Tax Lot(s) 8900; Lot(s) 5-6, Block 59, McClure and a vacated portion of 11th Street) in the C-4, Central Commercial zone. Development Code Standards 2.425-2.445, Articles 9 and 11; and Comprehensive Plan Sections CP.005-CP.025, CP.050 to CP.055, and CP.190-CP.210 are applicable to the request.
2. Conditional Use CU14-03 by the Lower Columbia Preservation Society to locate an approximate 1,000 square foot office with occasional transient lodging in an existing multi-family dwelling structure at 1030 Franklin, #2 (Map T8N-R9W Section 8CC, Tax Lot(s) 2400; Lot(s) 7, Block 45, McClure) in the R-3, High Density Residential zone. Development Code Standards 2.150-2.185, Articles 9 and 11, and Comprehensive Plan Sections CP.005-CP.025, CP.040-CP.045, CP.240 to CP.255, and CP.215-CP.230 are applicable to the request.
3. Variance V14-02 by the Lower Columbia Preservation Society from the required 2 off-street parking spaces for a proposed approximate 1,000 square foot office with occasional transient lodging with zero off-street parking in an existing multi-family dwelling structure at 1030 Franklin, #2 (Map T8N-R9W Section 8CC, Tax Lot(s) 2400; Lot(s) 7, Block 45, McClure) in the R-2, Medium Density Residential zone. Development Code Standards 2.150-2.185, Articles 7, 9, and 12; and Comprehensive Plan Sections CP.005-CP.025, CP.040-CP.045, and CP.215-CP.230 are applicable to the request.

A copy of the application, all documents and evidence relied upon by the applicant, the staff report, and applicable criteria are available for inspection at no cost and will be provided at reasonable cost. A copy of the staff report will be available at least seven days prior to the hearing and are available for inspection at no cost and will be provided at reasonable cost. All such documents and information are available at the Community Development Department at 1095 Duane Street, Astoria. If additional documents or evidence are provided in support of the application, any party shall be entitled to a continuance of the hearing. The location of the hearing is accessible to the handicapped. An interpreter for the hearing impaired may be requested under the terms of ORS 192.630 by contacting the Community Development Department at 503-338-5183 48 hours prior to the meeting.

All interested persons are invited to express their opinion for or against the request(s) at the hearing or by letter addressed to the Planning Commission, 1095 Duane St., Astoria OR 97103. Testimony and evidence must be directed toward the applicable criteria identified above or other criteria of the Comprehensive Plan or land use regulation which you believe apply to the

decision. Failure to raise an issue with sufficient specificity to afford the Planning Commission and the parties an opportunity to respond to the issue precludes an appeal based on that issue.

The Planning Commission's ruling may be appealed to the City Council by the applicant, a party to the hearing, or by a party who responded in writing, by filing a Notice of Appeal within 15 days after the Planning Commission's decision is mailed. Appellants should contact the Community Development Department concerning specific procedures for filing an appeal with the City. If an appeal is not filed with the City within the 15 day period, the decision of the Planning Commission shall be final.

The public hearing, as conducted by the Planning Commission, will include a review of the application and presentation of the staff report, opportunity for presentations by the applicant and those in favor of the request, those in opposition to the request, and deliberation and decision by the Planning Commission. The Planning Commission reserves the right to modify the proposal or to continue the hearing to another date and time. If the hearing is continued, no further public notice will be provided.
