## **Key Placement Requirements:**

- Place the sandwich board at the Parking "T" or Parking "L" marking between parking spaces.
- **Clearance**: Maintain a **minimum 48-inch clear width** along the sidewalk to comply with ADA accessibility standards.
- **Proximity**: Ensure the sign is adjacent to your business's frontage.
- Avoid: Do not place signs on corners or obstruct building entrances, exits, or legally parked vehicles.
