Input to the City of Astoria on the Development of Heritage Square

The City of Astoria, like many small towns, has had to adapt to changing economic conditions. It had lost its traditional industries, fishing and timber processing. Big box, national chain retailers made many small downtown businesses unprofitable and many were forced to close. Astoria did not escape these problems, but adapted to the changing conditions.

Astoria realized that it's strategic location on the Pacific coast and alongside the Columbia River made it desirable as a recreation/tourist destination. Being within driving distance of Seattle and Portland made Astoria accessible. Astoria's rich historic heritage was also an important tourism draw. Like many tourism destinations, Astoria also has become an active center for the arts. The Liberty theatre, historic visitor sites like the Flavel House, the Maritime Museum, the County Historic Museum, Fort Clatsop, the Film Museum, and the cities historic business district and many Victorian era homes create an attractive atmosphere for visitors. Hotels, restaurants and breweries now occupy former business buildings and accommodate Astoria's tourist industry. The River Walk and redevelopment of the Mill Pond have improved the river fronts appearance and helped tourists and residents access the river. Astoria has also become attractive to retirees, bringing new residents and renewed energy to Astoria.


The focus of Astoria city government throughout the recent past was to revitalize and enhance the city. Many changes have been made. The City has successfully adapted, but the city must not forget it is heavily dependent on tourism.

The purchase of the Safeway property and creation of Heritage Plaza were part of the cities adaptation to a visitor/tourism/arts economy. The central business core has transitioned quite well, but empty buildings are still prevalent. More can be done to grow the tourist industry in Astoria.

The Cities proposal to abandon completion of Heritage Plaza in order to provide low income housing in central core would be a mistake of epic proportion. It would negate many efforts and investments made to revitalize and enhance the vitality of Astoria's business district. It would, in fact, likely do the opposite. There are better locations for low income housing, as well as locations that provide more long term expansion possibilities. No one wants to examine first hand the shortcomings of society while on vacation.

I ask that the city to end its investigation into developing low income housing in the central business core and focus instead on alternate locations better suited to this need.

What about... HERITAGE SQUARE

Astoria's Heritage Square block is singularly the **most significant piece of public property in the City of Astoria**, with the greatest potential of any other piece of land in the City's inventory.

What ultimately happens there is pivotal and permanent for the direction of our City.

The location is uniquely central to our Historic Downtown, right next to Astoria City Hall.

The City, when it acquired the site, was fully aware of the developmental potential impacts of this location to our City. We couldn't have this site's fate just be cast to the wind as to how it might be redeveloped. The location was too critical, too impactful to leave it to chance. That is why the City originally acquired it.

The redevelopment of this site, whatever that ends up being, represents a **critical turning point for the revitalization of our uniquely historic downtown**. The redevelopment of the site marks either a continuation of the resurgence and rebuilding of our downtown that started some 25 years ago, a revitalization which fully embraced the **proven tenets of Main Street redevelopment strategies**, or it will forever change our downtown into something else entirely, something different, something inconsistent with those solid **urban planning goals the City and downtown businesses have been working towards for the last quarter of a century.**

One of the basic tenets of successful urban planning in a busy downtown environment, and a common goal for Main Street strategies, is making room for a downtown open public space. Making a place where a great variety of public events may occur. Gatherings, festivals, markets, music, theater, relaxation, and just simple relaxation and play. The heart of our town. This **strategy is proven to be a powerful generator for sense of community and a solid engine for economic stimulus and opportunity**. There are numerous studies that verify this. Not wishful thinking, but proven benefits. The Heritage Square site was deemed perfect for just this purpose, as no other site could ever fulfill this purpose, and a very engaged public bought in to this strategy after months of engagement with a proactive and thoughtful, forward thinking City government.

But now, staggeringly, this critical site, this very heart of our Downtown is on the bargaining table without anywhere near what would be the barest of due diligence having been performed on part of our good City, to redevelop it in an entirely different direction from what the public had bought into, and this has happened without the kind of critical debate and public engagement and due diligence such a critical site deserves. There have been no impact studies. None. No thorough, thoughtful investigation of other possible locations for the development of affordable housing, not only with public property on the table, but private properties as well, for location, after all, matters.

LOCATION, LOCATION, LOCATION. That is what will matter for the two separate missions of affordable housing and Clatsop Behavioral Health to really succeed. There have been no studies as to reveal what the impacts of these two endeavors will actually have on our downtown. This is not the kind of process that can be done without us, the owners of this property being fully informed and cognizant of what we should really expect to happen. We have tools to examine these outcomes, tools to take as much of the guesswork out of it as possible. That is what good urban planning is all about. But, no such tools have been employed.

Best wishes and best intentions are NOT GOOD ENOUGH here. This site is simply too critical and irreplaceable not to have done the requisite and thorough due diligence that is fitting for this unique location.

This process and the fate of the Square and of our Historic Downtown has got to be a fact based and thorough examination of all the impacts of what is being proposed. Impacts such as parking, impacts on CBH clients, and the impacts of those CBH clients on a downtown setting, impacts on our downtown merchants, on our blossoming tourist trade, on the Liberty Theater, The Eliot Hotel, the Senior Center, the American Legion, the tour boats, and on and on. This location, and what happens or does not happen there will have a lasting and major impact on the immediate and entire area, so we had damn sure better get it right.

For the City to give this property away, this most important piece of public **property in the very heart of our downtown**, over to a private developer whose sole purpose is to make money, without first conducting thorough and relative impact studies, having first had thorough and open public conversations, and first having acquired a meaningful public buy-in, is simply not acceptable.




