### Item 6(a): <u>Authorization to Award Construction Contract – Bond Street</u> <u>Retaining Wall Project</u>

As a result of a landslide in 2007, Bond Street has been closed to two way traffic. Only one westbound lane of traffic is allowed limiting east west traffic to Marine Drive. The goal of the Bond Street Retaining Wall Project is to open the street to two-way traffic.

On August 6, 2018, the Astoria Development Commission authorized staff to solicit bids for the project. One bid was received for the project from Big River Construction in the amount of \$584,496. This is the lowest responsible bid.

The Engineer's estimate for this project is \$465,000, including contingency. The bid received exceeded this estimate by almost \$120,000. The higher cost appears to be related to the risk associated with work in a slide area, the retaining wall construction limitations, and a lack of Contractor availability in the required timeframe.

Due to schedule constraints associated with dry weather construction, City Staff recommends awarding the project to Big River Construction. After award, City Staff will work with the project team and Contractor to determine if any cost saving opportunities exists. Funding for this project is available in the Astor West Urban Renewal District Fund.

It is recommended that the Astoria Development Commission authorize award of a construction contract to Big River Construction in the amount of \$584,496 for the Bond Street Retaining Wall Project.

### Item 6(a): Bond Street Retaining Wall Authorization to Bid

As a result of a landslide in 2007, Bond Street has been closed to two-way traffic. Only one westbound lane of traffic is allowed limiting east west traffic to Marine Drive. In August 2015 a geotechnical analysis was performed to study the feasibility of constructing retaining wall so that the roadway could be restored to two-way traffic. The results of the study concluded that a wall could be built under the right conditions.

A recently completed boundary expansion of the Astor West Urban Renewal District (AWURD) includes the project area.

In 2017 Cornforth Consultants were hired to provide geotechnical and civil engineering design services for the project. The project was put on hold due to a very wet winter (2016/2017). The additional rainfall contributed to groundwater and inclinometer readings that were unfavorable and increased risk to the project. City staff decided to postpone the work until 2018 with the hope of improved conditions.

Staff and the consultant have been monitoring the slide activity. The information available indicates that construction late this summer is feasible. Plans and specifications have been completed and Staff has prepared an updated construction cost estimate. The anticipated construction cost is \$465,000 and the funding is available from the Astor East Urban Renewal District fund.

We anticipate a notice-to-proceed for construction in early September. Completion of the retaining wall and associated utilities is targeted for early October, with roadway and sidewalk work being completed by mid-November.

It is recommended that the Astoria Development Commission authorize staff to solicit bids for the Bond Street Retaining Wall Project.

**Commission Action:** Motion by Commissioner Price, seconded by Commissioner Nemlowill, to authorize staff to solicit bids for the Bond Street Retaining Wall Project. Motion carried unanimously. Ayes: Commissioners Jones, Nemlowill, Brownson and Price, and Mayor LaMear. Nays: None.

### **DISCUSSION/ANALYSIS**

As a result of a landslide in 2007, Bond Street has been closed to two way traffic. Only one westbound lane of traffic is allowed limiting east west traffic to Marine Drive. The goal of the Bond Street Retaining Wall Project is to open the street to two-way traffic. The project will include installation of a retaining wall, and improvements to utilities, curb, sidewalk, ADA ramps, pavement and striping.

On August 6, 2018, the Astoria Development Commission authorized staff to solicit bids for the project. One bid was received for the project from Big River Construction in the amount of \$584,496. This is the lowest responsible bid.

The Engineer's estimate for this project is \$465,000, including contingency. The bid received exceeded this estimate by almost \$120,000. The higher than anticipated cost appears to be primarily related to the risk associated with work in a slide area, the retaining wall construction limitations, and a lack of Contractor availability in the required timeframe.

Due to schedule constraints associated with dry weather construction, City Staff recommends awarding the project to Big River Construction. After award, City Staff will work closely with the project team and the Contractor to determine whether any cost saving opportunities exist. Funding for this project is available in the Astor West Urban Renewal District Fund. The City Attorney has reviewed the attached contract and has approved it as to form.

### RECOMMENDATION

It is recommended that the Astoria Development Commission authorize award of a construction contract to Big River Construction in the amount of \$584,496 for the Bond Street Retaining Wall Project.

#### AGREEMENT

#### 1.00 - GENERAL

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between Big River Construction, Inc., 1050 Olney Ave., Astoria, Oregon 97103, hereinafter called "CONTRACTOR" and the Astoria Development Commission, hereinafter called "COMMISSION." Acting on behalf of the Astor West Urban Renewal District, an Oregon urban renewal agency, hereinafter called "DISTRICT."

#### WITNESSETH:

That the said **CONTRACTOR** and the **DISTRICT**, for the consideration hereinafter named agree as follows:

#### 2.00 - DESCRIPTION OF WORK

The CONTRACTOR agrees to perform the work of:

### BOND STREET RETAINING WALL PROJECT

and do all things required of it as per his Bid, all in accordance with the described Bid, a copy of which is hereto attached and made a part of this Contract.

### 3.00 - COMPLETION OF CONTRACT

The CONTRACTOR agrees that the Work under this Contract shall be completed by the following dates:

- Substantial Completion 75 days from Notice to Proceed
- Final Completion 90 days from Notice to Proceed

If said **CONTRACTOR** has not fully completed this Contract within the time set or any extension thereof, it shall pay liquidated damages in accordance with Section 00180.85 of the General Conditions.

#### 4.00 - CONTRACT PRICE

The Contract Price for this project is \$584,496. Payment will be made in accordance with ORS 279C.560 including progress payments at the end of each month. Retainage will be withheld in accordance with ORS 279C.550 - .565.

#### 5.00 - CONTRACT DOCUMENTS

The **CONTRACTOR** and the **COMMISSION** agree that the plans, specifications (including the ODOT/APWA 2015 Oregon Standard Specifications for Construction and Contract Documents defined in Section 00110.20 of the Contract Documents General Conditions and all modifications thereto) and bid are, by this reference, incorporated into this Contract and are fully a part of this contract.

#### 6.00 - NONDISCRIMINATION

It is the policy of the **COMMISSION** that no person shall be denied the benefits of or be subjected to discrimination in any District program, service, or activity on the grounds of age, disability, race, religion, color, national origin, sex, sexual orientation, gender identity and expression. The **COMMISSION** also requires its contractors and grantees to comply with this policy.

### 7.00 - CONTRACTOR IS INDEPENDENT CONTRACTOR

A. CONTRACTOR acknowledges that for all purposes related to this Contract, CONTRACTOR is and shall be deemed to be an independent CONTRACTOR and not an employee of the DISTRICT, shall not be entitled to benefits of any kind to which an employee of the DISTRICT is entitled and shall be solely responsible for all payments and taxes required by law; and furthermore in the event that CONTRACTOR is found by a court of law or an administrative agency to be an employee of the DISTRICT for any purpose, DISTRICT shall be entitled to repayment of any amounts from CONTRACTOR under the terms of the Contract; to the full extent of any benefits or other remuneration CONTRACTOR receives (from DISTRICT or third party) as result of said finding and to the full extent of any payments that DISTRICT is required to make (to CONTRACTOR or to a third party) as a result of said finding.

Bond Street Retaining Wall Project City of Astoria, Oregon Agreement Page 1 **B.** The undersigned **CONTRACTOR** hereby represents that no employee of the **DISTRICT** of Astoria, or any partnership or corporation in which a **DISTRICT** employee has an interest, has or will receive any remuneration of any description from the **CONTRACTOR**, either directly or indirectly, in connection with the letting or performance of this Contract, except as specifically declared in writing.

#### 8.00 - SUBCONTRACTS - RELATIONS WITH SUBCONTRACTORS, ASSIGNMENTS AND DELEGATION

A. Assignment or Transfer Restricted. The CONTRACTOR shall not assign, sell, dispose of, or transfer rights nor delegate duties under the contract, either in whole or in part, without the COMMISSION'S prior written consent. Unless otherwise agreed by the COMMISSION in writing, such consent shall not relieve the CONTRACTOR of any obligations under the contact. Any assignee or transferee shall be considered the agent of the CONTRACTOR and be bound to abide by all provisions the contract. If the COMMISSION consents in writing to an assignment, sale, disposal or transfer of the CONTRACTOR's rights or delegation of the CONTRACTOR's duties, the CONTRACTOR and its surety, if any, shall remain liable to the DISTRICT for complete performance of the contract as if no such assignment, sale, disposal, transfer or delegation had occurred unless the COMMISSION otherwise agrees in writing.

**B.** CONTRACTOR may not discriminate against a subcontractor in awarding a subcontract because the subcontractor is a minority, women or emerging small business enterprise certified under ORS 200.055 or a business enterprise that is owned or controlled by or that employs a disabled veteran, as defined in ORS 408.225. If CONTRACTOR violates this prohibition, the DISTRICT will regard the violation as a breach of contract and may either terminate the contract or exercise any other remedy for breach of contract.

#### 9.00 - NONWAIVER

The failure of the **DISTRICT** to insist upon or enforce strict performance by **CONTRACTOR** of any of the terms of this Contract or to exercise any rights hereunder shall not be construed as a waiver or relinquishment to any extent of its right to assert or rely upon such terms or rights on any future occasion.

## 10.00 - LABORERS AND MATERIALMEN, CONTRIBUTIONS TO INDUSTRIAL ACCIDENT FUND, LIENS AND WITHHOLDING TAXES

**CONTRACTOR** shall make payment promptly, as due, to all persons supplying **CONTRACTOR** labor or material for the prosecution of the work provided for this contract.

**CONTRACTOR** shall pay all contributions or amounts due the Industrial Accident Fund from **CONTRACTOR** or any subcontractor incurred in the performance of the contract.

**CONTRACTOR** shall not permit any lien or claim to be filed or prosecuted against the **DISTRICT** on account of any labor or material furnished.

**CONTRACTOR** shall pay to the Department of Revenue all sums withheld from employees pursuant to ORS 316.167.

### **11.00 - CERTIFICATION OF COMPLIANCE WITH TAX LAWS**

As required by ORS 305.385(6), **CONTRACTOR** certifies under penalty of perjury that the **CONTRACTOR**, to the best of **CONTRACTOR's** knowledge, is not in violation of any of the tax laws described in ORS 305.380(4).

### 12.00 - CITY OCCUPATION TAX

Prior to starting work, **CONTRACTOR** shall pay the **CITY** occupation tax and provide the Public Works Department with a copy of occupation tax receipt. **CONTRACTOR** shall, likewise, require all subcontractors to pay the **CITY** occupation tax and provide a copy of the receipt to the Public Works Department prior to commencement of work.
