CHANGE OF VENUE

The **Astoria Planning Commission** will hold a public hearing on **Tuesday, May 26, 2026** at 5:30 p.m. in the Astoria City Hall, Council Chambers, 1095 Duane Street, **City Library, Flag Room, 450 10th Street**, Astoria.

The purpose of the hearing is to consider the following request:

Conditional Use Request (CU26-03) by Liberty Restoration Inc. to locate allow for light manufacturing in the commercial kitchen of an existing commercial building at 1203 Commercial Street (Map T8N R9W Section 8CA, Tax Lot 5700; Lots 1,2,8, and 7, Block 62, McClure's Astoria) in the C-4 (Central Commercial) Zone. The following criteria are applicable to the request: Astoria Development Code Sections 2.425-2.445 (C-4 Zone), Articles 7 (Off-Street Parking and Loading); 9 (Administrative Procedures); 11 (Conditional Uses); and Astoria Comprehensive Plan Sections CP.050 to CP.055 (Downtown Area); CP.200 (Economic Development Goal 1) and CP.202 (Economic Development Goal 3).

The location of the hearing is ADA accessible. An interpreter for the hearing impaired may be requested under the terms of ORS 192.630 by contacting the Community Development Department 48 hours prior to the meeting at (503) 338-5183.
