For Fiscal Year Beginning July 1, 2026

The City of Astoria established the tourism promotion and development program to provide funding to organizations in Astoria that will increase tourism in the City. Funding is provided through the Promote Astoria Fund which receives its funding from Transient Lodging taxes. **The actual amount of funding will depend on resources available and will be finalized during the annual budget process.** Awards will not be final until the 2026-2027 Fiscal Year Budget is adopted by the City Council in June 2026.

Applications must be received by February 27, 2026, at 5:00 pm.
