RESOLUTION NO. 23-37

A RESOLUTION ESTABLISHING WATER, WASTEWATER, STORM DRAINAGE, TRANSPORTATION, AND PARKS SYSTEM DEVELOPMENT CHARGES

WHEREAS, the City of Astoria ("City") has adopted Ordinance No. 23-06 to create a System Development Charge (SDC) program and provide a uniform framework for the imposition of development charges in the City and provide equitable funding for orderly growth and development; and

WHEREAS, in compliance with ORS 223.304 FCS GROUP has prepared a report dated October 17, 2023, entitled *City of Astoria System Development Charge Study* which justifies the establishment of a combined reimbursement and improvement SDC within the City; and

WHEREAS, the City desires to phase-in the SDC to help alleviate cost burdens on new development in a manner that is consistent with the *City of Astoria System Development Charge Study*, dated October 17, 2023, and in a manner that complies with ORS 223.297 – 223.316.

NOW, THEREFORE, THE CITY OF ASTORIA RESOLVES AS FOLLOWS:

<u>Section 1.</u> The report, *City of Astoria System Development Charge Study*, dated October 17, 2023, is adopted as the statutory methodology required by ORS 223.304. Planned capital improvements listed therein shall serve as the list of capital improvements required by ORS 223.309(1).

<u>Section 2.</u> The SDC unit rates are adopted as follows:

<u>Section 3.</u> SDC unit rates contained in this resolution will be effective on December 1 of 2023 as indicated in Section 2. The SDC unit rates, as indicated in Section 2, will be reviewed within 1 year from effective date.

<u>Section 4.</u> For all development types other than single-family residential, the following SDCs shall be imposed. Water SDCs shall be imposed on the number of MCEs

of Astoria System Development Charge Study, dated October 17, 2023. Sewer SDCs shall be imposed on the number of MCEs indicated for the development's meter size as shown on Exhibit 3.5 (page 12) of the City of Astoria System Development Charge Study, dated October 17, 2023. Storm drainage SDCs shall be imposed based on the size of impervious surface area (ISF) added by the development. Transportation SDCs shall be imposed based on the number of new PM peak hour person trip ends (p.h.p.t.) added by the development as indicated in Appendix B (starting on page 30) of the City of Astoria System Development Charge Study, dated October 17, 2023. Park SDCs shall be imposed based on the number of residential equivalents added by each development type, as indicated by Exhibits 6.8 and 6.9 (page 24) of the City of Astoria System Development Charge Study, dated October 17, 2023.

Section 5. As derived from the City of Astoria System Development Charge Study, dated October 17, 2023, Appendix C, when charging SDCs to single-family residential developments, the stormwater SDC shall be based on the size of impervious surface area (ISF) added by the development. The number of MCEs for the water SDC, MCEs for the sewer SDC, PM p.h.p.t., and residential equivalents shall be based on total square footage of the heated floor area of each single-family dwelling unit as follows:
